Start and finish at Sons of Rest Shelter, in east end of Tower Grove Park, near Grand and Arsenal (see map below).

COURSE

5K loop in tree-filled, scenic urban oasis of Tower Grove Park.

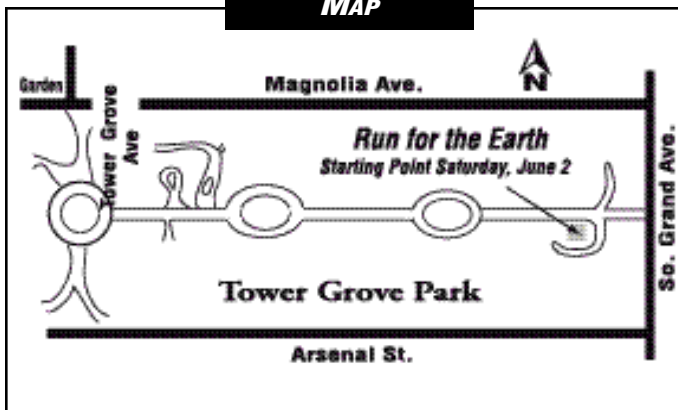

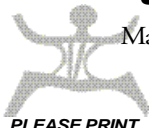
